ABOUT THIS HANDBOOK

Ministry of Corporate Affairs (MCA), Government of India has authorized Indian Institute of Corporate Affairs (IICA) notified under sub-section (1) of section 150 of the Companies Act, 2013 to create and maintain an online databank of Independent Directors under the Companies (Creation and Maintenance of Databank of Independent Directors) Rules, 2019 and the Companies (Appointment and Qualification of Directors) Fifth Amendment Rules, 2019.

This handbook provides an overview of the databank, including introduction, key objectives, empanelment and registration process, and available knowledge resources.

The handbook also provides overview on features of the databank, such as availability of online eLearning courses, online proficiency self-assessment test, and corporate access to databank of profiles of Independent Directors.

This handbook is intended to be used by all Independent Directors who are required to empanel with this databank within 3 months of commencement of the rules stated above.

Aspiring Independent Directors and designated officers of companies can also use this handbook as a ready reckoner on various steps involved with empanelment, registration, and accessing knowledge resources.



INTRODUCTION

The Government of India is committed to bring continuous improvement in ease of doing business, ensuring market integrity, expanding corporate governance landscape, and enhancing investors' overall confidence.

Better Corporate Governance is central to the idea of improving market integrity and investors' confidence. The factor that strengthens the corporate governance framework the most, is the role played by the Independent Directors. To bring transparency and integrity to corporate boards, Independent Directors's conduct is seen as the benchmark.

Independent Directors are seen as the catalyst of change who bring value to the board and provide the right balance with their diverse and cross-functional professional skills.

To empower and strengthen them further, Ministry of Corporate Affairs has entrusted Indian Institute of Corporate Affairs with creating and operating an online databank for existing and aspiring Independent Directors.

The databank aims to build an eco-system of serving Independent Directors, aspiring individuals and companies. - Upon successful verification, click on the "Proceed" button to receive login credentials for the Databank on registered email and mobile



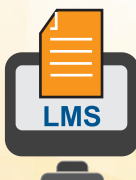

ONLINE PROFICIENCY SELF-ASSESSMENT TEST

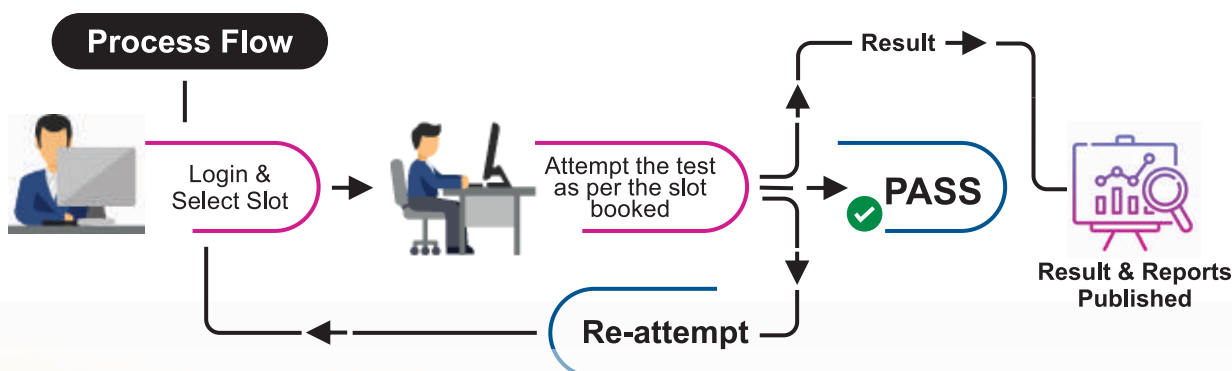
As per the Companies (Appointment and Qualification of Directors) Fifth Amendment Rules, 2019, every individual whose name is included in the databank shall pass an online proficiency self-assessment test conducted by the institute within a period of one year from the date of inclusion of his name in the databank, failing which, his name shall stand removed from the databank of the institute.

Rules have further provision for exemption from this test based on the certain conditions which will be duly calculated and notified to the empaneled Independent Directors well ahead of the test is made available on the databank.

This test will cover all the areas relevant to the functioning of Independent Directors, such as Companies Act, Securities Law, Basic Accountancy and Board Practice related topics.

- Multiple choice questions based on the courses available in the Learning Management System

Databank of Independent Directors aims to provide single-point access to the corporate to search Independent Directors as per their needs and criteria.



CORPORATE REGISTRATION PROCESS

Mandatory Requirement

To register your company on the Independent Director's Databank, you should first register on www.mca.gov.in

- Go to "ID Databank Registration" section under "MCA Services" and click on "Corporate Registration"
- Enter CIN details and click on "Submit"
- Email ID will be pre-populated. Click on "Send OTP"
- Enter OTP & click on "Verify OTP"
- Upon successful verification, click on the "Proceed" button to receive login credentials for the Databank on registered email



- Redirected to Independent Director's Databank
- Few basic details (Company name, current status, Registered address, etc.) will be pre-populated in the company profile page



- Provide additional Information
- Add two designated officers from your company who will also have access to the databank



- Review shared details
- Pay to access databank of Independent Director's profile and complete the company registration process
